CONTRACT AGREEMENT

 - (b) Bid Security/Earnest Money
 - (c) Performance Guarantee
 - (d) the bidding documents
 - (e) Acceptance Letter
 - (f) And the work orders
3. In consideration of the payments to be made by the Procuring Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Procuring Entity to execute and complete the services in all respects with the provisions of the Contract and bidding documents.
4. The Procuring Entity hereby covenants to pay the Contractor, in consideration of the execution and completion of the services of the Contract, the Contract Price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract and bidding documents.
5. The contractor accepts to provide the video making services at the bid prices submitted by the Contractor.

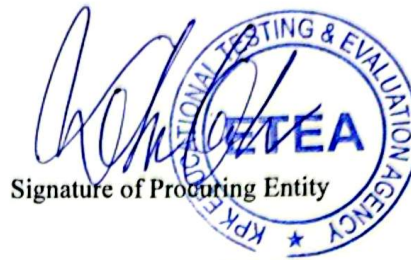
